

Delta Kappa Alpha Phi Social Agreement

I. Alcohol and Illegal Substances

In accordance with the CCOM and the Standing Rules of Alpha Phi International Fraternity, as well as the local, state, and federal laws, I will not consume alcoholic beverages if I am not of the legal age.

The Delta Kappa chapter's ALCOHOL POLICY PROHIBITS UNDERAGE DRINKING AT ALL Alpha Phi events.

I understand that if I am of the legal drinking age, I may not provide alcoholic beverages to others not of the legal drinking age.

Under no circumstances will I bring my own alcoholic beverage, open or unopened, to the event. The officer/s and sister/s in charge have the right to confiscate any alcoholic beverage that I bring to or take from the social event.

If I am found bringing alcoholic beverages or illegal substances to the designated meeting area, **I will not be allowed to attend the social.**

If I am found with an alcoholic beverage not provided by the present third party vendor, or if I am found with any illegal substances at the social, **I will be sent home immediately.**

I understand that **I will not be allowed to attend the event** if I arrive at the departure location intoxicated or under the influence of any illegal substance.

II. Smoking

I understand that all Alpha Phi events are smoke free.

III. Dates

I must sign the date release form prior to the social event. My date must also sign the Date Policy. **I understand that my date will be held accountable to the same standards and rules that I am.**

IV. Behavior

I understand that sisters and officers in charge at social events have the authority to put a stop to alcohol consumption or unacceptable behavior by myself or my date. **They also have the authority to send my date and me home at their discretion.**

The following include, but are not limited to, examples of unacceptable behavior:

- Refusal to accept Watchcare
- Vomiting
- Inability to control oneself
- Disrespecting the officer/s or sister/s in charge
- Disrespecting other sisters or dates at the social
- Physical or verbal fighting with fellow sisters or dates
- Performance of any sexual or lewd acts

I will enforce and accept Watchcare respectfully.

WATCHCARE began with our Founders, who bonded together to support each other for mutual growth. These women were vigilantly concerned about their sisters, people they cared about a great deal. They came up with three components of Watchcare; the first component is **the preservation of human dignity**, the second component is **risk management**, the third component is the **development of solid values and ethics**.

I understand that any sister sent home for unacceptable behavior will be required to be a sister in charge for the next social she attends. In the case the member has not yet been initiated that member will be put on social probation for the next social event.

V. Phi Buddy

A **Phi Buddy** consists of a fellow sister who is willing to watch out for me, hold me accountable, and understands they are responsible for my actions as well as their own; and vice versa.

If I arrive at the designated meeting area intoxicated or under the influence of any illegal substance, my date (if it is a date social) and I will be sent home. However, my Phi Buddy (and her date) will not be sent home.

If it is not a date social and I arrive at the designated meeting area intoxicated or under the influence of any illegal substance I will be sent home or escorted home by an officer-in-charge. My Phi Buddy can still attend the social and will join another set of buddies or a single Alpha Phi.

If I am sent home from a social due to a violation of this social agreement, my Phi Buddy (and her date) will leave the social with me (and my date) via taxi. A meeting with the VPPD will be scheduled with the Phi Buddies.

I understand that I am not allowed to leave the social alone. If I must leave, I must first inform the officer/s in charge. **I must leave via taxi at my own expense.** I will either leave with my date or my Phi Buddy, depending on the structure of the social.

Once I leave the social event, I understand that Alpha Phi is no longer responsible for me and I am not allowed to return to the location of the social event under any circumstances.

VI. Transportation

I understand that if I know in advance that my date or I will be LATE and/or need to LEAVE EARLY (via taxi service only) I need to inform the officer/s in charge.

I understand that at the completion of the event my date and I must leave on the bus, no exceptions.

I understand that the buses or other public transportation must go directly from the point of origin (i.e. a member's house, dorm, campus parking lot) to the location of the function and directly back to the original point of departure.

I hereby swear to the above stated Social Agreement.

Upon violation of the above stated Social Agreement, I will be sent home from the social and summoned to a Judiciary Board hearing.
