- Chemistry (1 SAH, 1 At-large)
- Communication Studies (1 CLS, 1 At-large)
- Computer Science (1 SAH)
- English (2 At-large)
- History (1 CLS, 1 At-large)
- Microbiology (2 At-large)
- Modern Languages (1 CLS, 1 At-large)
- Philosophy (2 At-large)
- Physics (2 At-large)
- Psychology (1 CLS, 1 At-large)
- Theatre (2 At-large)

To become a candidate for any senate position, a person need only obtain 20 signatures of faculty members, without regard to the number of other petitions they have signed, or whether or not they are eligible to vote for the candidate. Nominations must be returned to the Faculty Senate Office, 323 Graff Main Hall, not later than 4 p.m., Friday, February 17, 2012.
