Old Business

TTC Appeals update – Deadline for filing was February 4, 2022. US has 7 Appeals to review. US Exec Committee met with ASC Appeals team to ensure process is similar. Appeals Committee has training opportunities available before appeal meeting. Reviewed process as we know if thus far and fielded questions. The appeal process seems to differ by campus.

Campus signage/directories – Directories are planned for each building. It is a complex process. Adding digital signage to Graff entry way. Wittich has "way find signs" that are very tasteful.

CFA/Truman Lowe – US Exec Comm expressed concern regarding the building name process with Chancellor Gow. He was receptive to the comments and concerns. Moving forward to rename CFA with at the Board of Regents meeting.

1% Lump Sum – HR sent out notices to eligible US.

New Business

Budget 101/Remote work – Reviewing guidelines for remote work and flex scheduling. Counsel comments: Flex scheduling huge discussion around campus. Many departments would benefit moral wise by having workday options. Departments should discuss and provide feedback as to what would work for them. Departments like Custodial Services would still need to cover areas on campus. UWL has lost people because of lack of remote work options and flexible scheduling. Could we use flex scheduling as a recruitment tool.

Career Progression – Is back to being an option and being reviewed by System.

Exec. Updates – Dr. Hetzel meeting: Salary savings for UW Systems positions questions. There is not one. UWL sends those funds to System and then pays for the Shared Services. Hoping for

another 1% Lump Sum. Concerns: We need to be proactive to retain staff. USC is more than happy to give suggestions.

Provost Betsy meeting: Stipend for US Executive seats for professional development like ASC, Faculty Senate and Student Senate.
