CBA Assurance of Learning Plan Spring 2022

Goal: to create and maintain a faculty-led, sustainable, and systematic assurance of learning program that collects relevant data used to improve student learning.

Key Components:

• Course-embedded assessment of CBA learning objectives is conducted in the capstone course, *Applied Business Strategy* (MGT 449), every semester as an end-stream measure of student learning. Faculty from across the college evaluate student work using the common CBA rubrics. Not all learning objectives are assessed every semester, but rather on a rotating basis. (Please see schedule below.)

*The process for assessing this learning objective is described below.

- Each major within the CBA conducts course-embedded assessment to measure Competency in the Major (CITM). CITM is conducted on a twoyear cycle that consists of collecting data in the first year and reporting assessment results and implementing curricular changes in the second year. (Please see Appendix A for a calendar of CITM activities.)
- Core courses outside of MGT 449 conduct course-embedded assessment on a two-year cycle that consists of collecting data in the first year and reporting assessment results and implementing curricular changes in the second year. (Please see Appendix A for a calendar of assessment activities in the CBA core courses.)
- Assessment results are disseminated to faculty at all-college meetings and through a designated Canvas site.

- Core Course Coordinators meet once a semester to share information about their courses, for example changes to learning objectives, assessment results, and curricular changes, to foster a more integrated curriculum and appropriate scaffolding of student learning.
- Available technology is leveraged to promote efficiency and the sharing of information.
