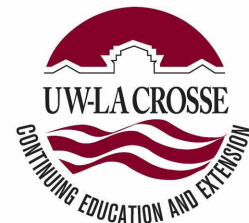

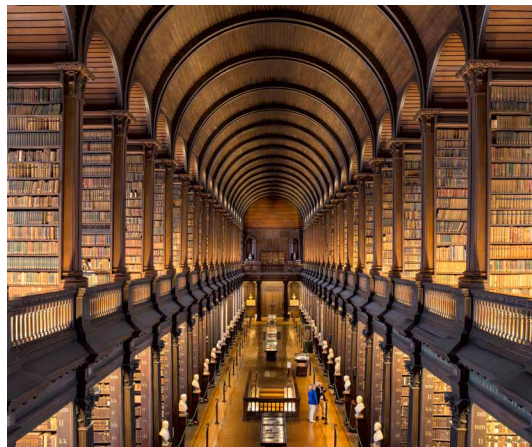

Treasures of Ireland Itinerary

Day 1: Overnight Flight to Ireland

Today board your overnight flight to experience the Treasures of Ireland.

Day 2: Arrive Dublin - Belfast Sightseeing

Arrive in Dublin and meet your **Tour Director**. Board your motorcoach and travel to Belfast, the capital of and largest city in Northern Ireland. Day 3: Giants Causeway - Titanic Belfast

Today travel to the **Giants Causeway**, often described as the Eighth Wonder of the World and declared Ireland's first World Heritage site by UNESCO in 1986. Shortly after arrival, you will see why it has become one of Ireland's top tourist attractions. Later visit **Titanic Belfast**, a museum on the site of the former Harland & Wolfe Shipyard where the Titanic was built and launched in 1912. Enjoy the evening at leisure in Belfast.

Meal - (B) Overnight - Belfast

Day 4: Belfast - Glendalough - Limerick

This morning depart Belfast and travel to **Glendalough** to see the ruins of St. Kevin's monastic site, a center of Irish Celtic Christianity. The area is also famous for its scenic vistas of the Wicklow Mountains. Continue onto **Limerick** for a two-night stay. Enjoy a **Limerick City Tour** to see the attractive St. Mary's Cathedral, King John's Castle and the Treaty Stone. Tonight is at leisure to enjoy dinner on your own.

Meal - (B) Overnight - Limerick

Day 5: Limerick - Cliffs of Moher - Galway

Today travel to the spectacular **Cliffs of Moher**. View the mighty Atlantic and the beautiful Aran Islands from atop cliffs that reach nearly 700 feet into the air. Travel through the **Burren**, an area known for limestone natural beauty. Later enjoy a **Galway City Tour** featuring St. Nicholas Cathedral & Eyre Square. Galway, "The City of Tribes" is a vibrant city with a great seafaring tradition. Tonight experience a **Medieval Banquet** featuring delicious food and traditional entertainment.

Meals - (B,D) Overnight - Limerick

Day 6: Limerick - Adare - Killarney

This morning stop in **Adare**, renowned as Ireland's prettiest village. Next visit the **Foynes Flying Boat Museum**, housed in the original terminal building in Foynes and said to be the birthplace of "Irish" Coffee. The port of Foynes was the fulcrum point for air traffic between the U.S. and Europe in the early 1940's. Later arrive in the charming & picturesque town of **Killarney** for a two night stay. Upon arrival embark on a **Jaunting Car Ride** into the Killarney

National Park. The horse drawn Jaunting Car experience ends at the Muckross House & Garden, a 19th century Victorian mansion on the shores of Muckross Lake. Take some pictures of the house and grounds before the short motor-coach ride back to your hotel. Tonight join your fellow travelers for dinner.

Meals - (B,D) Overnight - Killarney

Day 7: Killarney - Ring of Kerry - Killarney

Today travel along one of the most gorgeous coastal routes in the world - the **Ring of Kerry**. Focus your cameras on the majestic seascapes, mountains speckled with brightly colored farm houses and winding lanes bordered with luscious vegetation. Pass through the rugged mountains and stop at **Ladies View** for wonderful vistas of the Lakes of Killarney.

Meal - (B) Overnight - Killarney

Day 8: Killarney - Blarney - Dublin

This morning travel through the mountains of West Cork and arrive at the historic **Blarney Castle**. Will you dare to kiss the famous Blarney Stone, rumored to bestow eloquence upon those who kiss its surface? Visit the **Blarney Woolen Mills** to wander the enticing displays of Irish crafts. Later stop to see the **Rock of Cashel**, a group of Medieval buildings set on an outcrop of limestone. Later arrive in **Dublin** for a two-night stay.

TERMS

Credit Cards

PWD accepts Visa, Mastercard, Discover and American Express for credit card payments. We must get a signature on the reservation form or PWD credit card charge form for initial credit card charges. We can also accept a letter of authorization with the cardholder signature and the amount to be charged. Credit cards taken over the phone must be accompanied by the 3 digit security code from the back of the card. For final payments using the same card as the initial deposit, authorization to PWD can be taken via phone or email by the Group Contact or Passenger. ***PWD does not accept group leader/single source credit card payments for full or partial group final payments.*** Credit cards for final payments need to be in the name of a traveling passenger. PWD cannot take overpayments for services not being rendered by PWD via credit card such as own air. PWD cannot accept credit card payments in excess of what is due to PWD other than commission due to group/agency. The amount in total PWD can charge on a passenger credit card for a group booking cannot exceed the amount due to Premier for the group booking (other than commission). Credit card payments cannot exceed the Flyer Sell At package amount or PWD provided package of the traveling passenger and his/her roommate(s). PWD can accept group leader/single source credit cards for deposits.

Air Deviations & Gateway Changes

Any Air Deviation, Gateway Change or Own Air Arrangement must be submitted to PWD Reservations Dept in writing (email/letter/Res Form) 6 months prior to departure. Any Air Deviation involving dates of travel other than regular scheduled group travel dates will incur a \$150 per person air supplement for International Trips/\$75 per person air supplements for US/Canada. Any passenger requesting a different gateway (Gateway Change) from the group will not incur an air supplement but will be subject to air rate increases or reductions based on the Gateway. Passengers requesting Own Air will get the RT Air package reduction. One-way air, Triangular air or air involving stopovers is not permitted with PWD group air contracts (offer Own air reduction). OWN Air Arrangements
