V. Guest Speakers

#### a. GENA

i. GENA rep: Thank you I appreciate the opportunity to talk. I've been here to talk about the Grandview Emerson Neighborhood Association before but for those of you who don't know what it is, it is a neighborhood that is just east of here up around the marsh. It overlaps with campus as well. When this area became less active we took on this area. Today I'm here to talk about the eye sore you see on campus- the memorial pool. The neighborhood wants to do something better with that pool. The pool went through some phases and repairs until it was decided to close it permanently. It is a historical location though and served a great community role. We knew built in 1938 and it went well at first but the last 10 years hasn't been so good. What is the reason people don't use it?

a. Lenz: You'd cut your feet in the pool.

ii. It's actually different than that, it is a cold pool and a lot of people don't like that and by counties standards you have to have the pool at a certain temperature. That was the feedback we got from people. People see this as a deteriorating feature. It's changed over the years but awhile ago the pool

was the only thing there. In 1938 we had a very small neighborhood and it was built for everyone to go to. We are serving really tiny kids, and the outdoor recreation is also popular at pools today. We've got different ways of doing it. It's difficult to accommodate this in these areas- especially seniors and they've asked for a space, this is one of many things to do. We need opportunities for families to get outside, it provides connectivity with one another. It became the veteran's memorial in the 40's, what we did was employed a consultant because the city's timeline was different than what we wanted. We also saw that the city has a lot of things it's trying to manage. As a part of that report we generated some concepts, it came from the university, neighborhoods committees and those have expanded, really all the neighborhoods. It's at the very center of our community so it is positioned to serve everyone in the community and here we have the opportunity for a pool that doesn't require driving. It's clear people want to keep the pool in the same place. That does give us some flexibility but we think that the sidewalks and accessibility is important and that's why we want your opinion of this. The first design tries to keep the historic significance to most- most swimmers use this dimension- 25 yards, this would reduce it and would be more efficient but would maintain the original spaces. These are called WPA pools. We would line the pool with stainless steel. The second concept is to replace the pool completely which means to delist the pool as a historic place. The pool itself doesn't have architectural history. It would be appropriate for competition. These would offer spaces in those lanes, then what we've done here back which connects people like so, the third option is the compromise. People feel strongly with keeping the cross shape and not because it is a crucifix. A new concept would be more like a first aid cross with the same functional areas around the pool. We have technology so that we don't have to do too much demolition. A lot of the kids love water volleyball and basketball.

a. Rosa: You mentioned how not a lot of people are going do you think it's because Erickson is built more for kids, so what would we do to this pool that would make it better than Erickson?

1. And that's why we are going out and trying to get opinions. This would be a programming pool. Early morning hours and late night hours, this pool would have a longer time to be open. That's why this is different, middle schoolers don't like going to those pools but they need stuff to do and we want them to be attracted to this. We want to accommodate a lot of people but this should be a true swimming pool. That's really all I want to offer and

questions or feedback would be great, I see a lot of opportunities for people.

a. Garcia: What's the cost breakdown?

v. A neighborhood pool is about 2.5 million and that's why these designs need people to contribute to this, there are groups that will contribute. The new pool design is about 3-3.5 million. It depends on how you want to go about this and we really should capitalize on this. The nice thing about a pool like this is that we would save a ton of money because we wouldn't have to do constant repairs.

a. Gunaratnam: I heard there were things being dumped in the marsh?

1. That was sanitizing chemicals.

b. Roberts: Is there a plaque there that highlights the veteran's historical aspect?

1. No there isn't, and since we haven't decided on what to do with the pool yet we haven't had to make the decision on that quite yet.

c. Floerke: What's the current timeline?

1. We want the city to finish their request. \$250,000 is what it takes just to design it and there are a lot of people involved, if that's done in the next month or two then it would move on from there. We are just trying to get feedback to make the right decision later on. I think it would be great to open it in 2018.

d. Roberts: Is there anything to do to help?

1. Feedback is really the best thing for the concepts. We would like to make department and student contacts and we truly value your opinions.

e. Arney: Would there be snacks you could buy there?

1. Yes, in the development design it is there right now but we are trying to shy away from what other people are doing, in small businesses the difference between open or close could be between 5-6 people. We really just don't want to duplicate but encourage the small businesses around it to be able make money off of it.

# f. Given: Is the committee in charge of getting lifeguards? 1. Yes, that would be a standard and we would have to meet those. There are programs for safety instructors and they've expressed that it's hard to keep them around in the summer. We don't want to build more parking but it would

be great if the university was interested and helpful in this area. The neighborhood really has a lot of parking and we have more parking here than other locations.

g. Kallis: Is this being paid for by the city, neighborhood council or are you just looking for feedback?

1. Right now were just thinking and coming up with designs, there are larger needs. We know it will be reasonable in costs but we will be approaching a lot of people to get feedback. The city would pay a large part of this and there are different strategies for doing this. The neighborhood association is interested in helping. Thank you again for allowing me to come and speak.

#### b. Dr. Ryan Mckelley

i. I'm going to pull up some things. You may see a PowerPoint I had a chance to read your minutes from last week. Never when I was in college could I do what you are all trying to do. It looks like you're dealing with some heavy stuff and I'm not here to change anyone's mind but I am grateful for being here tonight. When Karlie came to talk to me we started talking about this idea of white privilege. I am a licensed psychologist and this is the first year I've been at UWL not doing a men's group. I've published multiple books. We went to universities and asked white males about their role at their college campus. We then went to marginalized communities and asked what they expect from white males. I'm weary about using the term expert but this is an area that I spend a lot of time on. I identify as a cisgender straight white male. In college, the cheapest way to go back and forth was on the greyhound bus. I met a lot of interesting people and there was one ride and all of a sudden an African American started running through the aisles saying "Kill Whitey" and he was trying to get everyone riled up. Someone, who was also African American stood up and defended me and told him to sit down. Why is this relevant? This could just be simple kindness, but if the roles were switched would I have had the guts to stand up and do something? Years later, the first company I worked for was a startup. To save money I went out with friends in Chicago and I would walk home through the green project and that was the failed housing project, when I was living there they were working on redeveloping it. A stranger came up to me and asked me what I was doing on the street late at night and he told me that it wasn't a safe place to be and he walked me home so that no one would hurt me. Would this have happened if I had a different social identity. What was it about me that was privileged? I think about these things but I share these because some

of you have done a lot of work on this and some of you have done little. I just want people to start talking about things that they haven't before. A couple caveats, this isn't about male bashing or white male bashing, it isn't. It's really hard for us to take these at truths but we need to hold these in context. Now we'll do an activity.

ii. Brever: We'll pick up with the agenda, the divide that we've seen in student senate is the same divide that senate has had since the beginning of time. And set up next year's senate with good ground to work on, that was the first of many inclusivity trainings that are going on in the next couple of months.

iii. Antelo: Hello everyone I am here on behalf, we are being sued right now, Christopher Rudolph is suing. He claims that this was in SUFACs recommendation and that it violated the green fund's bylaws. The trial is March 7 at 7:00 pm in 3135, you can be active participants, all you have to do is talk to the chief justice. The last thing I want to say is that there are constitutional changes, the court did make some suggestions if you have any questions.

ii. I'm speaking on behalf of another student, she brought up another issue, there was an international student in the policsi department and she asked if she could translate it into mandarian and the professor thought that was fine but they couldn't translate it. She was saying that international students pay a lot of money but she was interested in exploring this with senators, so if you are interested at all in working on that, please let me know.

#### VI. Officer Reports

a. President: Jacob Schimmel

i. Schimmel: Originally I was going to have nothing, but one thing came up and I was hoping not to have to use my veto powers during my time in office but that's not what I'm doing at this point I think it should be forwarded to a committee. #### IX. Committee Reports

i. Kallis: DOC met, we did a lot of discussion about the building and the fact that the all gender bathrooms keep locking.

a. Dr. Ringgenberg: I talked to the locksmith today and he said that he would check that out, but please keep me informed.

ii. Kallis: We also had a good discussion about teachers having students come to org meetings where they sit and take notes about us, so we had a discussion of what to do and how we can communicate that with the professors. We were discussing writing a letter, we are not something to be studied, do any of you have ideas?

a. Spielman: If they are doing that for research they are violating the IRB, but I feel like they would be violating privacy rights anyways.

1. Kallis: We've had grad students want to research us, but no one warns us before they are going to come study us. I know research goes through a process.

iii. Director of OMSS: It is not in my job description but I do understand people, but I think Will should be the person that would have to vet that. Here are two potential decisions 1) Give students the choice to opt in when you do research you feel that you should be paid, this will deter people from research but then it gives faculty, we don't have enough students on our campus for every project for race or sexual orientation. There is privilege with sexual orientation, I know some multicultural orgs have discussed that. I always ask for an IRB and if it is not approved I do not forward it on. There are protected things within the IRB process. iv. Dr. Ringgenberg: If they show up unannounced I would ask them what class it is for and I would gladly give them a call.

v. Director of OMSS: Some faculty think that they are exempt from the rules because I believe they should have had an IRB, as a parent I want to know the research you are doing on my kid. I want to know as a parent. I think this is a bigger issue but I think you should all talk about it. vi. Thomas Harris: The thing you need to realize is there is very little research on white people and all of this is going on and we have professors that are mostly white, either never talk about this or very little, I can't remember someone ever asking to do research on white people. vii. Rosa: What I used to do was that I would allow them to announce their project and if someone wants to speak to them after that is their choice, but I would also try to get them to participate.

viii. Quaschnick: It is very surprising that people don't have IRBs, I know that a grad student is supposed to sit on an IRB because that should never happen. That's basically what gives graduate research it's meaning. That should never happen so let someone know.

xi. Bhatoya: Would it be better to create a document to outline everything we are saying like: some think they are above the policy, idk maybe something that could be viewed?

a. Mason: We should talk to Provost Morgan, Faculty senate likes to make fun of our whereas clauses, they poke fun at how thorough we are so I don't know how well putting another document would do. Granted when you go just to an individual meeting it has more of an effect than a resolution. This could just be a conversation, I just looked at the last faculty senate meeting there is no open body forum but there is not representation from every department.

x. Quaschnick: These grad students doing research illegally could go back to threaten the accreditation of the university. This is why IRBs exist so that people are not being tested on illegally.

xi. Kallis: Anyway, so I said it before and I'll say it again our meetings are not pea tree dishes, thank you for everyone's input.

xii. Hodges: I think there is a little misclarification, it's mainly the undergrad students that we are having problems with.

xiii. Rosa: It is a lot of undergrads and it's given to them like go to a diversity org and reflect. I have received a lot of emails like that as well. xiv. Reinke: SSB met today and we are thinking about putting up a stand to advertise scholarships and then we talked about clocks. People liked the third one in from the left on the bottom. If anyone has any opinions, keep in mind the size of the clocks. I'm open to anyone's ideas on that. xv. Given: I was just going to echo, since I lost my glasses I like bigger numbers.

iv. Giles: SUFAC met on Monday and took the feedback from last week. This body did an informal vote and they decided that would be best to take from the reserves and in SUFAC we decided to do a cut of about 1% across all orgs except green fund and UPASS. This was done not in the way to scare orgs it was decided because this structural deficit isn't going away and we need to take into consideration. I would be happy to talk to people more.

a. Bhatoya: So we already met with people about this -Kim Blum specifically, but they want to emphasize that they are 43% fundraising and they pay dues. That's something that would have to be accounted for. Safety and health is a concern. If we decrease the funding further then we look at programs not being able to provide food if the budget allows for lunch, things like this. We have the money from the reserves and it's not a good thing to always go back to but I think it's a good idea. Most people don't know what SUFAC is and they have negative attitudes with what we do.

v. Giles: One of the options was exempting athletics, we thought it would be more ethical to cut from all. So the other thing is that CAB is broke by about \$28,000. When T-pain cancelled the stage costs added up because everything had to be done twice so CAB wasn't able to come close to breaking even.

vi. Dr. Ringgenberg: They are asking for \$28,000 for the rest of the events but as of now they don't have the money. This is an issue because we want to continue to have events and programming for the new building.

> a. Spielman: T-pain twice was very expensive and to continue events we have to come up with this money. We sold out the concert so if he would've showed up the first time I don't think we would be in this.

vii. Kallis: This is not a good feeling that orgs are being cut but I know that all budgets are very tight, there is no increase. We are getting speakers to come in with the budget we do. Mumbletech everyone wasn't able to go because of the budget and now you're proposing another cut, that is not okay when there is \$100,000 that isn't being used. This is terrifying to me and the fact that your goal is to get your reserves down to \$72,000. Instead of making it more difficult for the pride center to have events. I don't understand where SUFAC is coming from and they should be and I will come to SUFAC if this is the way that things are being talked about.

viii. Given: First I would like to ask what the meeting room is? x. Gunaratnam: What are your options right now?

a. Ames: Likely the money for cab will come out of the reserves so that is what will spend that down, the other option to cut was to take it from one shots. As it relates to funding, I really believe that the people in SUFAC sees the value in all of these orgs and no one on that committee wishes to see any orgs cut but we all understand what the economic climate is like as well. CAB we are trying to explore some options. If it is a contingency request, but the potential that might not come to senate is possible.

xi. Floerke: I guess I just don't understand SUFAC's thought process on that. At the end of the day it's not your budget and it's the student's money and when we came here and did a poll you should have listened to that. I don't know why you didn't listen to that. Does anyone want to address that?

a. Brever: We will see this at one point, we will have the opportunity to discuss it further.

xii. Tahiri: The thought process behind this was the issue with CAB and where that money would be coming from, if we did that on top of the \$6000 covered then we are getting upwards of about \$30000. Today there is a possibility of the seg. fee opt out and for that fear we want the reserve to be as large as we can have it, so keeping a healthy size in reserve fund. I hope groups don't see this as a punishment but rather a product of circumstance that comes from an enrollment decline. If we don't take it out now we'll just keep having the same issue. That was the thought process there. Not so much of being punished or that we don't xiii. Bancker: We have committees for a reason and if they were easy decisions to make then we would talk about it all together. I just want to say that I trust the SUFAC committee.

xiv. Bhatoya: I think it's misguided to say that CAB's \$28000 deficit then Student Senate 2016-2017

1. Gunaratnam: I know you have good intentions but it can still have adverse effects.

v. Antelo: There are people who are generally concerned about this because they love to hear you speak, they are genuinely concerned with you trying to take away the seats. I would address the director and senator to meet with those people.
