The first is that some of you know that last year SA passed the indigenous land policy and the academic staff and faculty staff haven't passed it yet but those conversations will be taking place soon. The more people to show support, the better, we will be meeting again, February 13th at 10 am. Also I'll be going to student reps this weekend we'll be talking about a number of issues and the student regent is one of those. The application filled out by each applicant will be talked about. Lastly the governor will be here on February 7th at 12:15 pm in 3310. He might be unveiling somethings about the budget but I plan on being there and you are welcome to join.

• Student Regent Voting

i. Brever: Does anyone have any further questions about what the student regent job would entail?

a. Floerke: Are they at every student reps meeting?

1. Brever: No, not at every meeting. We will do up to 5 minutes to speak, the candidates will all read their statements and add any comments they wish and then we can ask them questions if they like. We'll vote to narrow it down to 2 and then we will do a second round on those two.

ii. Kallis: As a representative of the students, I would want to represent the wants and needs of the students. There are different ideologies and ideas and hearing those ideas is important. From being a member of my campus pride center. I feel that I can continue you this with even more outreach and will give listening to every topic. People who only listen to what they want aren't open to new ideas. I understand I'm coming to this position with my own bias but I feel that since I am aware of the biases I know that when making decisions I can better represent the students. To be honest I really want the

students to have this voice on the regents. There are so many within the system who don't get a voice. I want to be able to reach out to as many people as possible. It is important to have a student voice and I would love to be that voice for people.

a. Schimmel: Would you be able to make it to the monthly meetings?

1. Kallis: I do have a vehicle, so yes I would be able to. b. Schimmel: How would you come to agreements?

1. Kallis: I think that the best way to represent someone is to have all of the sides to the issue to try to come to a compromise.

c. Giles: Is there any issue that you are not willing to compromise on?

1. Kallis: I feel that my viewpoints are sound and that there really isn't something that I just don't agree with no matter what. As long as someone argued with facts then I think that a compromise is attainable.

d. Burgess: If you were elected in this position what issue would you choose to work on first?

1. Kallis: I think that with the board of regents in the last couple of years, the stagnation of expanding on space is a big problem. They haven't approved any buildings other than science buildings. I know there is a lack of expansion in a lot of other areas, if the board could open up, that would be great and I would be willing to talk to other campuses as well.

iii. Tahiri: First and foremost, I would like to thank Senator Bhatoya, it's a positive reinforcement to be nominated for something. Secondly, to answer the questions I would balance the needs of the students and of the system. I believe that as a student I feel that placing the needs of other students first would be best, to balance I think that I would try to go into things with an open mind. Increasing tuition is a problem. We want an education but it is expensive; I would request and encourage the exploration of these goals and act in an ethical manner at all times. In my family I was raised to believe education is liberation and that it provides hope. I have seen access and lack of access, my grandfather was denied the opportunity to go to school. Perhaps his struggles could have been skipped. My father from Macedonia was blessed to be taken in and learn English and Spanish. My father is now a teacher and helping kids go through what he went through. I think about my grandfather, and I think of what could've happened to my father if the educational system left him behind, perhaps I wouldn't be here. Education to me is too important to miss out on, it molds the future of our nation, the wellbeing of our citizens, and strengthens the community. I want the UW system to be a system that will allow anyone to get an education.

a. Schimmel: What do you think will be the number one or number one issues?

1. Tahiri: I think the topic of affordable education. In the UW system we're not getting the funding we need so finding methods

of ways to increase tuition but that are only necessary and getting increased funding would be my focus.

b. Kallis: Do you have a plan to balance the shifting majority's?
1. Tahiri: It might be hard for me to balance others biases but I think that I can get better at putting my personal biases to the side which will allow myself to not force myself into a decision.

c. Floerke: What would you do to make it more aware of the board to ensure that they are taking measures to stay at one of the top research schools in the US?

1. Tahiri: I would try to show them that the UW system is special and being here I have felt that each of us here really cares about the progression of our education and that we need to really care about the research facilities.

d. Elvaker: It's a deciding factor about how much money you get from grants, loans, financial aid, I guess with a tuition increase, what is something that you would want to increase?

1. Tahiri: I think that increasing grants would be great, but to faculty I don't know how much power the board has. I think that affording college is extremely important.

iv. Hodges: Hey, how's everyone doing? I am a second year student and apart of BSU. Strong, caring, diligent, knowledgeable, these are just a few characteristics of a leader. We need someone who understands intersectionality and not just different groups but being born in different groups. This person has been so hard working, a first year student, she has gone above and beyond, attempting to bring another major to this campus, we are already one of the top schools. We need someone who can speak for the people, not just what's right but also what being a good person is all about. I think all of you should give your vote to Senator Kallis. She knows what it's like to be a senator. She has done so much for the Pride Center. She has done so many things and advocated for so many clubs. She understands how to really get to other people. I want you all to think about this and I'm a man and the board is mostly men, yes people like me have done all of they can for me to be here but women like Eleanor Roosevelt, without people like that and people like me they wouldn't have been able to go to school. It takes more than just one person ruling everything and it's the collective that gets things done. I want to defer my vote to Senator Kallis.

v. Smarnack: I am the RHAC nomination. To answer the question, the biggest thing I would want to do would be to increase communication. To do that I would use my communication skills and technology. I have never gotten a poll from the student regent and I think that would be a great idea to get a better idea of what the students want. I would like to use the faculty to get to know the ideas as well. I think that representing everyone is extremely important. I'm looking to communicate with everyone in hopes to represent

a. Schimmel: What would be your top priorities?

 Marinack: The board has total control over buildings, even including this school, we put in a bid for a new residential hall. UW Platteville used a private contractor and saved about \$1.8 million dollars. Throughout that process we can expedite that.
 Steffan: Would you be willing to educate yourself on your privilege

and being willing to educate yourself on the diversity?

1. Marinack: Absolutely, if I had to choose one word that would be it. I'm taking a cross cultural psychology class but knowing my limitations as a straight white male but now that I have it different than a lot of people here and I would need to educate myself on this more to better represent myself and others on this issue.

vi. Given: I am a sociology major minoring in ethnic and minority studies. The board of regents is very powerful and we want to make sure that we get a student who will represent all of that and hopefully it will change so we can get someone elected that we want. Especially in this day and age, it is hostile, taking a step back and realizing where I stand and how I can represent. I represent the student side of the spectrum. Will I truly get the opposite side of where I stand- no, so I would like to step down and give it to Senator Kallis.

vii. Ames: I think that the person with the majority should be the winner- at least 51%

XIII. New Business

a. SA1617-029: Resolution Approving Green Fund Project

i. Ames: Another green fund request, there was a weird thing going on with the email but we got it on time. This deals with LED stage lighting and 5 years prior they felt that LED stage lighting hadn't come far enough and it wasn't developed the way they wanted it to be, the request is roughly \$51,000, the entire cost is \$176,000. So, the HPL fixtures have not been purchased yet and nothing has been installed. HPL use 570 watts, LED is 120 watts. 20% energy usage. LED fixtures need to be replaced about every 10 years and bulbs in HPL – the gel cost- colored and needs to be replaced often. Essentially, this is the project and SUFAC felt it was appropriate to pass this.

1. Kallis: Do you know what type they are getting? A can is the smaller ones and the type you were talking about are different.

a. Ames: It hasn't been purchased yet so they can still make that decision.

ii. Bancker: What was the difference in cost?

1. Ames: That wasn't mentioned in the request but the initial funding for the lights will be used for training.

a. Kallis: to speak to that there is actually a huge cost, LEDs cost far less because the up keep is way less and the gels are dangerous at times.

iii. Floerke: I think that these will do well, so I motion to suspend the two-week rule.

1. Motion to suspending 2-week rule, Second: Burgess

i. Ames:

2. Dr. Ringgenberg: When I think about this process, once we actually get the paperwork, it will be about 2 months before we can push this. I will spend the next week making sure we get what we want and where the money is coming from is the last piece of the puzzle.
