- b. Jillian: this resolution is having admissions to look at students differently. Currently it looks like on their website penalized student who leave class to peaceful protest. We want to recommend to look at restructuring this. UW Madison just made a statement that they will not do penalized students for this.

- c. Tahiri: I'm not really sure how this could end up in the hands of admissions. My question is how much school would I have to miss because of protesting that I would not get into school.
- d. Jillian: this is less about amount of days missed, but more about if the student got an in school suspension due to protesting and that having an impact on their admissions.
- e. Tahiri: there are schools that do this?
- f. Jiliian: Yes, some schools may increase the penalty for missing school because they left to protest.
- g. Tahiri: I cant see how this would impact the admissions process.
- h. Kaliis: Can you add me as a sponsor? I really like this because I know of certain schools that will mark detentions for walking out of class. Admissions received your "record" and they do use that information to decide if you will be allowed acceptance at this school. I know high schoolers in the area that are currently planning protesting so this hits close to home. Its not just missing a day of school its about walking out.
- i. Giles: We have to go out side the opinions we have here because we already got in. Survivorship biases is at play. Due to the apparent mass protests this would be in admissions best interest.
- j. Khan: This is good because I don't want to normalize school shootings.
- k. Beckwith: I agree with Senator Tahiri, I believe that schools that make it aware that they will be punished they shouldn't do it. I don't support this resolution because it is politically charged.
- 1. Jurecki: I'm confused on what our admissions office can actually see. I recommend that someone speaks with admissions office first before we discuss this so we can know our school's current policy.
- m. Marinack: I think it is important to make a distinction between a kid skipping and a kid being politically active. I have a problem with the words for gun violence. I believe it is a specific thing and I think that needs to become more generalized.
- n. Silva: I think this is a biased stance saying that it is just for gun violence.
- o. Jillian: I would totally be open to the changing of wording.
- p. Dickler: I think there's danger in that. I feel like this is important to protect those protesting gun violence because they may be more specifically target due to its politically charged content.
- q. Tahiri: given that you don't have a lot of detentions I am not sure that one detention will bar you from this university. Also, I don't want it to get twisted that if this doesn't get twisted that if this doesn't pass that we are enabling gun violence. Unless we know La Crosse's policy, I think you can still take the risk. Wouldn't it be better to say im not going to be at school today instead of just walking out. I believe know right is being infringed upon.
- r. Giles: I think we are getting a little a head of our selves. I think to say that rights are being infringed upon is not right. It is not in our jurisdiction to make comments like that. I think we can definitely recommend to our admissions staff this resolution.
- s. Kallis: I think finding out our Admissions policy is a good idea. Oh, its case by case? Okay. I think this is a good discussion got have with our admissions. We should be active about his because if a student is worried about getting into college this can definitely help.
- t. Vu: There is the process of appealing the decision of admission. So that is an option as

- c. Marinack: is there a possibility to open that up to more students who are interested?
- d. Larry: I believe they are maxed at 35 or 40. But, we can recommend that other organization do it.
- e. Khan: Can we get tampons in the boys bathrooms.
- f. Schimmel: That's a work in progess with administration. We can possibly do something on our end but the Chancellor is indifferent to the idea. He is concerned with the unnecessary media that could surround it.
- g. Larry: I think we can have those discussions. I know when it happened in the fall that politicians called us asking us what are we doing. We need to strategically think about how we are doing this. I am sure we can put baskets in the other restrooms as well.
- h. Khan: Can we do something with sustainable landscaping?
- i. Haley: Its in the Green Fund bylaws that we cannot do that. If it has a functional use it is debatable.
- j. Khan: Overnight visitor paring ends at 6:00am. This is inconvenient because you have to get up really early.
- k. Khan: DOC wants to have a voter registration event. Schimmel can you help us out getting people registered to vote.
- 1. Schimmel: We can register people online now.
- m. Alicia: What do you think about holding an event to get more students registered and to get more info about who is on the ballot. What do you guys think about doing something like that?
- n. Schimmel: I think that would be a really good idea. Its also good ot mention that next election you will have to register to vote again.
- o. Alicia: the disabilities committee hasn't been running in a couple years. Please respond and sit on this committee because its important
- p. Alicia: I was also informed that some language on the paperwork in the HSC to start Transforming is transphobic. Also I am looking to get ALANAs seat permanent in Senate or to make permanent Woman of Color seat.
