Today you are voting for protecting those who protest gun violence and I hope you support this. - a. SA1718-032: Resolution to Recommend Admissions Not to Hold Protesting Gun Violence Against an Applicant
 - i. Jillian- I met with Cory the head of admissions at UWL on Monday and we went over things. As for suspensions and expulsion, he goes back to the policy and does it case by case and looks for something that isn't peaceful and academic. He said that if someone was to call him, that that wouldn't effect their position. I'm meeting with him tomorrow and I want to tell him that this is something we are doing. Motion to add: therefore be it further resolved add Vice Chancellor Betsy Morgan
 - 1. Passes
 - ii. Hahn- 4th whereas- it says students have a right to feel safe in their living, defend why that is a right? By what authority is the right to feel safe laid out?
 - 1. Jillian- that was going along with the right to life, if you're worried about living and your future
 - iii. Hahn-When you were speaking to director of admission, did you acquire the amount of cases this is happened
 - 1. Jillian- it is case by case basis. They could turn way from academic suspensions or expulsions. It could be also a protection threat to the university
 - 2. Hahn- So there are no instances where someone was denied acceptance by their actions?
 - a. Jillian- No but that is not in the resolution. We want to make sure it is in line

 - iv. Hahn- I'm picking up that students have a right to feel safe that others don't but if someone wanted to protest against gun control or protest gun ownership would this resolution also cover to admissions those students also be protected

- a. SA1718-033: Giving Asian, Latina, African, Native American Womyn (ALANA) a Permanent Seat within Student Senate
 - i. Sabah- motion to change the therefore be it resolved from bylaws to constitutions1. Passes
 - ii. Sabah- First and foremost, I would like to welcome the members of ALANA, SAPA and others who've come to the meeting. It is wonderful to have your support with us tonight. We want you all to have some

background, so let's start with the first Whereas: Feminist Standpoint Theory, founded by sociologist Dorothy Smith, states that "marginalized groups are socially situated in ways that make it more possible for them to be aware of things and ask questions than it is for the nonmarginalized."Women of color have historically been excluded from decision making bodies, their voices silenced or ignored. This resolution is a step forward in acknowledging that history and making strides to amend it. Our school prides itself on diversity and inclusion but we need action, a senator in this room, that reflects those values. ALANA is one of the oldest diversity organizations and has significant attendance and has a large presence on our campus not only through their general meetings, but through their events, especially the Phenomenal Womyn Dinner (which is April 19 btw) as well, we felt it was important to give them a seat at this table. When ALANA was looking for someone to fill the seat, many new members were willing. We have the people needed to fill this seat in the future. ALANA has grown a lot this year, and I expect it to keep on growing since research shows that campuses are becoming more and more diverse. Women of color might not always seek their college senator because they don't feel like they can relate to them. Women of color face discrimination and have experiences unique to them because of the intersection between race and gender. We need to give them a senator they are comfortable going to. ALANA stands with our most oppressed populations: trans women of color, women of color with disabilities, our lgbtq+ women of color. I'm not just here for the members of ALANA, but for anyone who feels like their needs and experiences aren't being heard. Because of our own experiences of oppression, we are more likely to empathize and identify with other vulnerable populations in a way that could be very helpful for discussions here in Senate. We should always be looking for more perspectives and more voices on Senate to make UWL as respectful, understanding, and inclusive as possible.

 - vi. Jillian- under God isn't relevant to everyone and I think that is a part to it
 - vii. Ethan- wasn't this a supreme court case a few years back and I want to know how they ruled
 - viii. Hahn- yes it was a case but it was relating to something else. The issue I have is sure faculty senate or other govt bodies don't do it but there has to be uniformity between our bodies. We aren't Madison or Eau Claire, we don't need to be the same as other schools. If you don't want to say under god or the pledge of allegiance no one is stopping you. I don't see that is an issue.

- c. SA1718-035: Resolution to Amend Election Bylaws in order to Extend Date of Spring Elections

- Glaus: it's hard to write out cuts. I think it's better to verbalize. AIDAC is the fee taken from our tuition. It's a fixed fee and we allocate this to the same body of people. There are only 3 or 4 people that didn't get their money this year. We had to cut 36.
- Silva: I want to speak to what Senator Hodges said. As you can see all of these things are very important and there is a rational behind these cuts.
- Kallis: In response to Silva... I understand that all of these are supper important, but I'm confused why their budget isn't being maintained?
- Silva: The cuts are here because all the entities asked for more money except 4.
- Glaus: There has been a 3% increase in student help. This was contracted in based on the line that it falls into because it falls under full time jobs.
- Kallis: Campus climate has come into here to give us teach-ins. I think their services are great. I can say the same thing about everything on this list but I want to talk about this one.
- Medugno: So, personally I think that the learning center is getting more money than they should be. I think they should be cut.
- Hodges: I was saying that cultural affairs is high impact and that this cut would definitely negatively affect students. Everything on this list is important, but in my experience, this is what I feel.
- Xiong: So, hate and bias team thing is also housed in Campus Climate. They hold a symposium every year. I feel like that brings a lot of attention and education on campus and in the community. They hold a lot of events that are high impact to students.
- Dickler: you mentioned the Learning Center was a mess when you
