  - a. Jen Shilling
    - i. Schilling- thank you for the opportunity I have represented this campus since I was elected in the state assemble in 2011 state senator representative Monroe and I serve as the senate democratic leader. I'm the class president of 14 democrats. I'm a UWL alum from 87-92. I've had a fantastic time here, I live on main street and as a state senator I'm here a lot. My fam and I feel welcomed on campus we love the union and we play games and bike on campus. We feel very welcomed as a family. We love the experience this campus brings and the economic impact it has on the region. I want you to have the same experience I had and make connections with professor and get an excellent education. Not sure if I could get in now because it a top-notch campus. Should be proud of the work you've done here. The budget has been challenging with the government and with the UW system president. You've been active and had students came down to lobby on issues such as public safety, sexual harassment, and students regions. I have been in support of the board of regions and supporting bill 992 that would've had a greater impact on students impacts and recommendations to governors. I think it is important to have that opportunity and have that opportunity to represent the system and campus. I'm a strong advocate of this campus I do serve on leadership 2% 2% raise for professors on campus. There have been peer compensation and what we need to, moving our faculty away to their campuses. It was long over due. At the 11<sup>th</sup> hour of session, the session that will never end. Since being gaveled we've been on the floor for 16 days since January 2-18. This year we have been in this year and we scheduled to adjourn last Wednesday and the last couple weeks. My attention is on the safety and rallies at the capital. The school safety is fresh in my mind due to the governor. It is lacking in some areas and looking at traumatic care. I think the root of school safety is calling for reforms on gun safety, I'm not as far as 24 hour waiting and age of purchase, bump stocks and background check. Put forward a grant and want to talk about want you are concerned about on campus. The last 3 weeks has been about public safety and how do we deal with that. Also, recently there was a call for 2 special election seats the governor appointed 3 last year and we are trying the get another special elevation. Went to court and was denied and he had it appealed and was

denied. Yesterday it went to a third court, and was denied and the judge said he has to have the election by tomorrow. That has been what is consuming me with lawsuits and appeals. The leadership pin and the senate intro to 1<sup>st</sup> Friday to eliminate the seats because the mood of the elector. This is an abuse of power and the election is a right and not it is not right to not be represented for a year. We'll see if it goes to the supreme court, sad we have to go to these lengths. Going into that I think government should be doing his job and not create chaos. We are suppose to be in adjourned for the year and half of the senators are up for elections. Its been a tough environment for the last several years. We need more friends supporting the university, expand your horizons, and mind. four years you go and stretch yourself, listen to speakers, really learn about yourself , the world, others. This is a learning experience with your peers and classmates to learn, Thank you for serving on this board, I wasn't on here when I was on campus. I served on the country board rep for this campus and I hope his ins inspires you to represent community service after. Questions?

- 1. Schimmel- we really appreciate your support. As you know one of the topics lately was the opt out from last year. The JFC ordered a committee by UW and I was on it to decide the allocated fees. They said what had to be done and we didn't have a choice. The opt out had a few items that leg didn't like but we voted out things that you don't want to cut. The concern is the allocable is open for an opt out and I didn't know if you heard
  - a. Schilling- I met today with the new secretary of department of administration and gatherd all the budgets. It stats this summer and DOA by October. I didn't' ask about that but we should keep an eye out for that on what the governor does moving forward. Also it is exciting to see the continue change of landscape because you as students have stepped up.
- 2. Schimmel- on the topic of sexual violence, we worked with Billings to get a draft on what we had been talking about. Hoping something advances with that. Is there is another bill proposal.
  - a. Schilling- I wrote one on sexual violence in relationships, but I'll look at the one you are referencing
- 3. Kallis- I know that the governor who had connections on board of regions and I don't know how much voice you have there talking on those. I'm curious about the \$75 late fee. I know there are other ways schools do it. If you don't pay it by the due date you'll get the fee and then paying your tuition forward there is interest. The UW regions say each campus has to have a fee when students don't pay on time between \$0-100 and a lot of universities, 7 total, that have chosen 75 and when our university was audited that was something we wanted to change, it is a recent change and it is affecting a lot of minorities
  - a. Schilling-I was not aware of that, ill take a look at that.
  - b. Kallis- also there has been things said about shared governance being restored after it was stripped
    - i. Schilling-There was legislation to restore it. I think we

I enjoy this it is a privilige. I like to be your voice. I want to do the best that I can in the time that I have
- 5. Marinack- these last elections have caused political division on campuses. On what you've seen do you have any suggestions to open up a more corporative communication channel on college campuses
  - a. Schilling- Some of the trainings I have had on servant leadership is how do we not talk past each other but recognize we need safe places where we can disagree and not make it personal. I'm trying to find things outside the capital environment to be social to be helpful. I have tried to reach out to senators to find common ground. Trying to get the one on one relationship. We are at a heighted state of disagreement. I don't know how we need to see the facts. If you demonize people you don't know how can you create relationships. We have to figure out a way to get past that. It is about listening to others and find a common ground. We need to have good reflective communities.
- 6. Gunaratnam what would you say is one of the biggest things you've learned
  - a. Schilling-I am inspired by ordinary people who do extraordinary things. I'm a people person so I love the fact that there are creative a hard working path of opportunity and success. Good people are doing good things in our communities. Dream big. I never thought I would be serving on the senate for the state. The beauty of the state is that we believe in the promise of tomorrow.
