 - a. Kallis: I move to amend the agenda to include under discussion, discussion about the consitution
 - b. Approval of Agenda
 - i. Passed
- V. Guest Speakers
 - a. Jacque Marcou La Crosse City Council
 - i. Discussed student housing in La Crosse and the student population connecting with city hall in relation to issues coming up with parking and lack of communication between city hall and the university and getting more students involved in conversations. Also talked about the new downtown neighborhood association and getting students to participate. Discussed ideas of possible quarterly meetings with the mayor and opening lines of communication between city hall and the university with representatives from this body to bridge the gap and debrief with the mayor. Contact Jacque if anyone has ideas for involvement with the city government. The MyLax app is a good resource to check out what is happening as well as cityoflacrosse.org. Also brought up were spring elections for districts 1-6 for city council in April, if anyone is interested in running, feel free to contact Jacque.
 - b. Justice Weaver La Crosse City Council
 - i. Gave an update on the city parking situation in hopes to find middle ground on situation. There will be no further updates until after January city council meeting.
 - c. Nora Garland Grandview-Emerson Neighborhood Association (GENA)
 - i. Discussed parking and the neighborhood revitalization commission who meets monthly to talk about issues that impact neighborhoods. Explained issues with parking over the years and hopes to find common ground. Also discussed climate change and finding solutions as well as encouraging other modes of transportation. Talked about the possibility of implementing parking benefit districts to help improve neighborhoods.
 - 1. Jurecki: Can college kids come to your meetings?
 - a. Garland: I usually reach out to Student Association if something like this comes up but usually no we don't. We'd like to work on tenant issues with you, but that's a further project.
 - 2. Horstman: There were some issues we heard coming into this. Residents are having issues with parking with the pilot program, do you think this would benefit parking in neighborhood?
 - a. Garland: It might push parking further out into neighborhood.

- People demand parking, if you go to a Packer game for example you pay more to park closer. I don't want to see it pushed out into neighborhood.
- b. O'Connell: There are some changes to bolster commuter parking, we do not have available parking like those people were saying.
- c. Garland: The new MTU director is interested in working with the university, someone who deals with sustainability. It would be good will with city if we can engage you with the conversation as well and use more ride share and mass transit.
- d. Seifert: I don't know anyone that just drives three blocks just to park. We are in the process dealing with seg fees discussing MTU.
- 3. Thering: You would not like to see in your neighborhood, so I'm curious as to what makes the neighborhood think their cause is more important than ours?
 - a. Garland: The people that live there are property owners. It is city issues that I am concerned about. You can never talk about parking without talking about housing, buying a home is major investment. It's about building equity and seeing things that impact that is anxiety producing. I would never want to put it in us versus you, it's important to talk.
- 4. Marinack: From conversations I've heard on issues, both sides are guilty. Has there been any concrete evidence that it's decreasing home value next to cometary? It sounds like a lot of guessing to me.
 - a. Garland: Excellent question, the people who are parking there and who they are, I would love some data.
 - b. Marcou: No, they are working hard. This has been managed horribly, they don't bring everyone to the table. I apologize for that, trying to get everyone to the table is what is frustrating.
- 5. Silva: Success for parking program, what would a success look like?
 - a. Garland: I think answer is that we would have some impact on the number of cars that drive into campus to reduce traffic in and out of La Crosse. We need to find creative green sustainable solutions and parking contributes to that.
 - b. Marinack: Do you think the city would be receptive to incentivizing people using those programs? Would they consider some way to compensate people who use those resources?
 - c. Garland: The conversation Jacque is talking about that we want to hear those ideas, we've had those conversations around similar issues.
- 6. Thering: This program is pay by phone, is there an alternative for folks without phones?
 - a. Garland: You're going to have to have some kind of phone, don't hold me to that but that's my understanding.

XI. Unfinished Business

- a. SA1819-020: Resolution to Ratify UWS Student Representatives Constitutional Changes
 - i. O'Connell: So far, 4 schools have rejected, 5 have ratified, and none of the other schools have done anything with it yet.
 - 1. Horstman: How is the accessibility for video / teleconferencing at these meetings?
 - a. O'Connell: There have been problems with past schools being able to hear. They've also done livestreams while communicating with chief of staff, but in general they have not been successful.
 - 2. Silva: My main issue is that I think it gives abnormal amounts of power to branched campuses because you can make quorum without you don't need all of those smaller campuses there.
 - 3. Neilsen: I agree with these concerns, but if quorum is never met nothing will ever be accomplished and nothing will get done.
 - 4. Kallis: I think I understand what they are trying to do in reflection of the merger and I think it makes sense. I understand your concerns, but I think the way the system is moving it makes sense for reps to mirror that in acceptance of the merger, to reflect what happening system wide. I am personally in favor.
 - 5. Boebel: I don't know exactly how it works, but how closely will the branched campuses be working with the main campuses?
 - a. Jurecki: It really depends on the school. Eau Claire is a great example, they are making outreach and are in tune with them, but that is not the case for many of them. No procedure is in place for that and they are still trying to work that out. It's very subjective to the school.
 - b. Boebel: If they try to reach out, I would be in support with that in mind that the campuses might not be super on top of it right now.
 - 6. Gerke: How long as this been a problem, is this something that has historically been a problem or is this just current?
 - a. Jurecki: There has never been a quorum issue until really this year, but never starting the year with no quorum.
 - 7. Horstman: in terms of quorum with new amendments, if schools leave half way will they still count? Or would it be counted off all the ones there?
 - a. Jurecki: They would reestablish if someone calls role call to

- ii. Failed: 10-8-2 (President Jurecki cast deciding no vote for 11-8-2)
 - 1. Jurecki: I'll vote no, I think that 2-years would lose their voice and we want every voice at the table.
- b. SA1819-022: Resolution to Approve the FY20 Green Fund Segregated Fee Amount
 - i. Woodmansee: Nothing has really changed from last time. This would just keep the amount that the green fund has the same.
 - ii. Kallis: call to question
 - iii. Passed: 19:0:1
- c. SA1819-021: Resolution to Approve the FY20 Allocable Segregated Fee Budget
 - i. Woodmansee: Just to clarify in support of this, if it's approved the changes would be multicultural events, sports clubs, org grants, and distinguished lecture series. This comes from what we just passed.
 - 1. Thering: What is the rationale behind orgs getting more?
 - a. Woodmansee: From SUFAC, multicultural events have had 3 additional orgs with no increase, sports clubs had to turn away groups due to budgets, org grants had \$40,000 worth of requests but only \$20,000 to give out. Most of these are pressing need.
 - ii. Silva: call to question
 - iii. Passed: 95: 0: 5
