WHEREAS it is the duty of the UWL Student Association to approve all use of Segregated Fee funded facilities by non-UWL affiliated groups; and

WHEREAS the Military Science Department, on behalf of the ROTC (Reserve Officer Training Corps) program, is required to participate in physical training courses for the program; and

WHEREAS ROTC has requested use of the MAC (Multipurpose Activity Court) of the REC on Tuesdays and Thursdays from 6:00-7:15 am to better fulfill that requirement; and

WHEREAS this is a very low-activity time for users in the MAC, unlike other areas of the facility and the program does not require any staff to facilitate the usage; and

WHEREAS 40-50 students are a part of this course, including some of which are coming from surrounding universities; and

WEHREAS because these students aren't paying a segregated fee for use of the rec, they will be charged a \$5 fee that will go toward the ID that will allow them entrance to the facility only during the aforementioned times; and
