**SA1819-036: Resolution Prohibiting the use of the Green Fund toward Student Stipends**

WHEREAS the purpose of the Green Fund reads “The Green Fund exists in order to fund projects that promote the ideals and practices of environmental sustainability at the University of Wisconsin La Crosse;” and

WHEREAS the Green Fund is funded by student allocable segregated fees and “can be used for sustainability projects on campus, including but not limited to: renewable energy, waste reduction and recycling initiatives, and energy efficiency projects.”; and

WHEREAS the Green Fund was established in 2008 with the approval of the majority of the student body with the understanding that it was a “Student proposed investment in renewable energy and energy efficiency projects for student-funded buildings on the UWL campus.”; and

WHEREAS the question has been raised whether the budget of the grant proposal may include a student stipend for labor invested in implementing a project funded by the Green Fund; and

WHEREAS since the Green Fund was established, the division of Facilities, Planning & Management, with the help of other UWL departments, have successfully implemented all approved Green Fund projects without student help; and

WHEREAS projects erected by the Green Fund are intended to be have a long-term application on campus, however student facilitation of a project cannot be guaranteed due to their student tenure; and
