#### a. Regent Woodmansee

My name is Olivia Woodmansee, I use she/her/hers pronouns. I'm currently a student here, majoring in mathematics and English. I also serve on the Board of Regents. As I began my term I realized nobody knows what the Board of Regents does. It's really important, you can make a bigger impact. You represent the UWL system and the UW system as a whole, just as I do. You make changes as well.

Three main entities, first is UW System. Thirteen four year institutions and thirteen two year institutions. There are the Board of Regents. 18 member body. 16 appointed by Governor, two students. One traditional and one non-traditional. I am the traditional student. Legislature and how they enact bills. We are here due to Chapter 36 of the Wisconsin State Statute. We are political, we can't avoid politics. 36.0.1.1 Public interest in the state of Wisconsin. The public wants higher education. We have a UW System mission. 36.07(1) Establishes the Board of Regents. 36.0.9(5) describes how the students of each institution advise the Chancellor. It says subject to the responsibilities and powers of the Board.

This describes the policies that govern the system. There are overarching branches. Right here, at the center, is where you are. We are all mandated by federal legislative rules. After this comes Wisconsin state statutes and Administrative code. Right underneath that is Board of Regent Policy documents. Then there's system administrative policies and procedures. Then there's system institutional policies and procedures and handbooks, which is more specific for each campus. Then finally the UW system administration.

First we're looking at UW system administration. This is UW-La Crosse's channel. At the top is the Board of Regents. Right under that is the President of the UW Systems. Right under system administration is office of the Chancellor. They work for collaboration across campuses. We're UWL but also UWL in the University of Wisconsin System. If there's a policy or program you enjoy at UW-Platteville, you could possibly make that work here. There's a President and a vice-President, much like how we're set up. Here are some offices in System. Now we've switched from D2L to Canvas. That was a system wide thing. Navigate/EAB is replacing WINGS and that's also a system wide thing. The 2020FWD is a strategic plan for the whole system.

This is President Ray Cross as of now, he just announced his retirement a couple weeks ago. As President he sets the UW System administration. Any board policy or system policy, the President is aware of that. President Cross not only visits the campuses once a semester but also lobby in Madison for education. He has the full executive responsibility for the operation and management of the UW System.

The Board of Regents is subject to establish the mission statement, determine the educational programs to be offered in the system and may discontinue educational programs, appoint a president of the system, and a chancellor for each institution. They allocate funds and adopt budgets for the respective institutions. They possess all power necessary or convenient for the operation for the system. There's five committees: Education, business and finance, capital planning and budget, research, economic development and innovation and the audit committee. The State of Wisconsin and the University of Wisconsin System is one of the most important connections in this State.

There's some things I really want you to take away. Think bigger than just UWL, think about what you want to see changed. What's something you think another institution should implement? Realize Student Government can make a difference. Give opinions and focus on state priorities for institutions. What I want to get across is that the Board and UW System Administration aren't constantly lobbying, that's where you all come in. That's, hopefully what I want you all to take away. # b. SA1920-024: Resolution Recommending an Inclusivity Statement for Faculty Senate

- i. Cayo: We were throwing around the idea of letting Faculty Senate to create their own diversity and inclusion statement. We could maybe change the language and then also include our statement and say they can use ours if they want.

"Whereas UW-La Crosse Student Association offers the following diversity and inclusion statement, which is modeled after UW-La Crosse Student Association statement, as an option for adoption by Faculty Senate and offers collaboration on said statement or any other statement with its original authors.

Discussion:

Stock: As a friendly, can we take UW-La Crosse and make it University of Wisconsin – La Crosse?

Cayo: could we right it so it says as an option for Faculty Senate instead of an option for adoption which rhymes, and I hate?

Fields: I don't know if this makes more sense, but could we change it from and to which?

Stock: Can we remove the comma and make it so instead of which it says that?

Packard: When it says, "an offer for faculty senate", could we make it so it says "and furthers collaboration" as a friendly?

Mccord: I know we've been putting the University of Wisconsin – La Crosse Student senate and faculty senate,

do we want to add that in the third line?

#### XI. New Business

- a. SA1920-025: Resolution in Opposition to UW System President Search and Screen Committee
  - i. Agterberg: I talked about this earlier. The search and screen procedure doesn't have any faculty or staff and only one non-traditional student on it. It doesn't really show the diversity of the UW System. Something we could add, is that people are opposing shared governance which is what we are as a body. Right now, there's only one person of color on the committee, so I think we should change that.

Discussion:

Wiza: I'm yielding to Olivia or Sita, but what was the process for who is on this committee?

Agterberg: President Drew Pearson put it together, so he is the Board President. There is no specific makeup for the UW-System President committee, this is breaking precedent in that there are no faculty on it. As far as the process goes, the search and screen selects them and then there's open forums and then then Board approves them.

Wiza: Does somebody have to approve this? How is that going to work?

Woodmansee: There's talk about making this smaller instead of eighteen to twenty people. In regards to who can change it, that would be President Peterson. You would send this to the Board. The committee is right now who it is.

Schock: Would it be beneficial to have a further be it resolved instead of "this document will be sent to certain individuals" or? Somewhere after the third whereas, people are talking about the language for people of color. Whatever language would be most inclusive on it. I would maybe defer to someone else.

Discussion:

Agterberg: It could be something like, "Whereas

there is a lack of representation..." I'm not sure here. "Of, diverse individuals." And then maybe including people of color. It could be marginalized people instead of people of color. Stock: Would it be possible to change it to "whereas there is a lack of diverse representation?" I feel like

those "of's" are a little confusing.

Ericson: "Whereas the current board doesn't reflect the diversity of the UW-System."

Jaume: We could add that it doesn't represent the full, or something like that.

McReavy: We could add something about, "and does not speak for the entirety of the UW System."

Schock: Maybe instead of cannot but "may have difficulty representing"

Packard: I was going to say "should" we could say "does not".

Ericson: We could say therefore may have difficulty.

Stock: Can we get rid of the "in" after difficulty? Neader: Call to question. Fiegel: Seconded.

Cayo: In general, I'm in support of this. You shouldn't have discussions regarding all of us without inviting everyone to the table. Agterberg can you talk about who is not in support of shared governance?

Agterberg: So a couple of things, her name is Regina Milner, she used to be the President of the Board of Regents. She spoke somewhat in favor of the UW-Steven's Points cut to the humanities and in general tried to limit shared governance. We used to have more shared governance. She was in favor of the free speech thing. Cayo: Would a whereas be discussing how that is problematic? Agterberg: We could talk about how shared governance means academic staff, faculty, and students are all about that. McReavy: This breaks precedent on what the committee has done in the past, how would you feel about in the first whereas, change

it to staff on the committee, which breaks precedent.

Discussion:

Stock: Call to question. Neader: Seconded. APPROVED.

Myers: How long has the committee been chosen now? Woodmansee: Two weeks, so since the announcement of this retirement.

Myers: Was the only reason that the makeup of the committee was different just because of that legislation of the members? What is the likeliness of this change?

Woodmansee: I can't speak to that and I also can't speak to why the committee looks the way it does.

Goodreau: Would it be possible to change it to "the current search and screen committee does not reflect the value of shared governance" does that make sense?

Mclain: Would it sound better if we did "this does not reflect the University System and the value of shared governance"?

Neader: As a friendly, could we change the first "and" to "nor the" ?

Cayo: Are we interested in mentioning the members past history of not valuing shared governance?

Stock: So, are you talking about adding another whereas? Cayo: Not necessarily, but we mentioned that potentially as its

own whereas. I don't know how I feel about it. Packard: That sounds like something we might add into the whereas that they don't reflect the diversity. The current makeup may be biased against.

Ozolins: I've been crunching the numbers with UW-System, something like 29% of students are non-white or non-traditionally white. So, I think if there's like, two of the nine members of the committee were other than normal that would account for balancing. Did I phrase that right?

Cayo: Are we suspending the two weeks rule?

Agterberg: We are not, because there are so many edits. Stock: Would it be possible to get sent the copy of this? With the backside? Motion to end discussion.

Mclain: Seconded.

#### c. SA1920-27: Resolution to Endorse the Joint Planning and Budget Executive Committee's Request to Create a Taskforce

Nielsen: If I'm remembering correctly, when the recession happened... Olivia?

Woodmansee: So, there is a cliff coming. Enrollment is going to drop like a hot potato. Since 2010, enrollment has steadily declined form high school graduation rate. Usually people are popping out 4-5 babies but now it's 1-2 baby households. That enrollment cliff is happening now but that demographic cliff is going to just wipe it right off. Cayo: Can I just ask why no more than ten?

McReavy: I have another friendly, in the fourth and fifth whereas there should be "and"'s.

Neader: I support this one. Is this something we want to suspend the two-week rule?

Nielsen: Yes please.

Neader: Call to question.
