  - a. Dan Kapanke
    - i. Kapanke: Thanks for what you do! Just a little about me- I am an alum from UW-La Crosse. I have two degrees in political science and economics and a teaching certificate all from this university. I have been a lifelong resident of La Crosse except for my service in the military. That's a little about me but I am happy to take any questions you have.

Zwettler: Thanks for taking time to come here today! At a previous meeting, we had Brad Pfaff, and someone asked him about the student debt crisis. So what would you do to help alleviate the student debt, if re-elected?

Kapanke: Eight years ago, there was a tuition freeze put in place by governor Walker. I would approve of doing that again. We have a new "sheriff" in town with Tommy Thompson running the UW system now and I think that with him in control, we will see good changes. I went to college and had a family of 3, worked 2 jobs with a family and I came out with some debt, but I worked it off over 10 years. There are no easy answers, but I would just encourage all students to take courses that will allow you to get a good job and take out minimal amount of loans.

Mathu: I was just wondering about public sector employees, specifically teachers, and if you had a plan to improve educators' lives.

Kapanke: K-12 education has always been at the top of the list and it will continue to be there. I know that we need to reward the really good educators with money. About 8 or 10 years ago, whenever act 10 went through, that caused angst but that all has passed. I have talked to teachers and their main concern is that they want to get students back in the classroom and are worried about COVID. They do a great job, and we need to make sure that our budget supports them.

Cayo: what is your plan, should you get this spot in office, about COVID-19?

Kapanke: My plan is to protect the vulnerable and for the rest of us, we need to get on to normalcy. Go to work and have confidence that we will be safe when we go out. I hope that the vaccine potentially coming out will be a good thing. Protect vulnerable and the rest of us, get on with our lives.

Flynn: I am involved in sustainability so I am wondering how you would fight for that if you are elected. What are your plans for long term sustainability solutions?

Kapanke: We are on a path where we are incorporating wind, air, and solar in our power grid. Power companies have spent money doing this. But they have also spent millions on their coal plants to make it a cleaner energy source. We should continue that course to incorporate green energy and put more emphasis on natural gas and make existing coal plants as efficient as possible.

Engebretson: I had the same question as Kelly about sustainability so instead I will focus on a certain aspect of sustainability. What are you going to do in regard to agriculture, energy and water conservation?

Kapanke: We have rules and regulations in place for nutrient managementwhich is manure. The agriculture business is one of the most regulated business we have but we must watch that they follow the regulations that are in place. There are people making them accountable, but it is one of our biggest businesses and we need to let it grow.

Schauberger: With your COVID-19 plan, you mentioned returning to normalcy, like you said normal, but how is it normal when thousands of people are dying, and they aren't just those at risk. Healthy individuals our age are dying. There are healthy people suffering and needing to be put on ventilators. It doesn't help the spread that a lot of people are asymptomatic. So you mentioned that you want to protect the vulnerable while allowing us to go back but never mentioned how that would work. What is your actual plan to protect vulnerable people?

Kapanke: The vulnerable are the people who have medical issues and they just need to be smart and use common sense and protect themselves more than the more healthy people. The lockdown has caused an increase in suicides in domestic violence and drug and alcohol abuse along with the mental strain of no normalcy with parents and the young kids. We have to balance that, shutting down the country because of some one's dying. We just have to take care of them. How is the state going to have the revenue to do these programs if we shut it down? Since COVID hit, La Crosse county has contributed \$50 million less to the state. Think about how much each county has lost to the closing down. Doing that again will leave all levels of government without money. We have to balance opening the economy while taking care of everyone. If masks work like they say they do, why aren't all kids in school? Onalaska opened this week and just announced closing on Friday. I don't know, can you help tell me the answer?

Schauberger: The federal government has no problem adding to its debt to solve issues, seeing as Trump has added trillions why not add to it. That seems like a good answer.

Kapanke: The CARES act was done because people were unemployed, and businesses weren't doing well. I ran into a young couple on the campaign trail. The woman had to balance working from home and teaching autistic son since schools closed. As a result of teaching the son, she lost her job. These are the horror stories that are arising. We need to re-open to get the money to support people like her in the COVID-19 pandemic.

L'Ecuyer: I have talked with educators who say that their biggest concern is getting in the classroom, but a lot of teachers are concerned. They don't want to get it and spread it. People are afraid. What would you say to these concerns?

Kapanke: Wear a mask. If they work like you say they do, that should be enough to re-open. I talked to an educator 20 minutes ago in Prairie du Chien. Forcing kids to stay home during this time is the biggest child abuse since they were forced to work in factories. They haven't been in school or with their friends since March. The mental strain is huge on the kids and parents. The numbers show that in La Crosse county 3.5% of us have gotten the COVID. We need to focus on the 96.5% that are safe and need to keep going. Closing everything down for that 3.5% is not the answer.

Ericson: In a recent debate you came across as being very against the 25% limit on capacity. There are bars in La Crosse that have not been enforcing social distancing and masks and are getting packed on weekends. How will you address these issues with bars and how do you justify your stance on this issue? And another question, I'm sure that you are aware that masks and social distance are the best way to address COVID 19, and you yourself have said that you wear a mask, but are you in favor of a statewide/nationwide mask mandate?

Kapanke: No, I am not in favor of that. If people are comfortable wearing one, they should wear one. We have to trust everyone to make common sense mandate. It isn't change anything. We can jam into Menard's and Kwik Trip and that's okay, but we can't go to a restaurant? They are going to be gone by the end of this. No one can live with 25 capacity of income. We see that restaurants are unfairly taking the fall. If you aren't safe going there, then don't go. You can order out. Who is choosing winner and losers? Who is to say that Menard's and Kwik Trip are good, but our local businesses aren't? We have families and businesses here that is everything. It isn't their fault. With 25% and they won't be able to stay open and pay the bills.

Schweiner: Would you be in favor of a non-partisan commission for redistricting?

Kapanke: Right now, that it is in our legislature that the maps are from the legislature and approved by the governor. Schweiner: You mentioned bars and restaurants. Would you be in favor of providing additional small business loans?

Kapanke: They already received some funding. It isn't sustainable and I m not sure we can keep doing that long term. It will have to come from someone's taxes. Why spend my taxes if we can just allow them to open to whatever they feel is safe? The restaurants don't want someone coming in there and getting COVID. It isn't good for business and they don't want that. They have safety features in place. They are practicing the social distancing and masks. They are doing it right. They are doing it right, and we need to trust them to protect their consumers
