WHEREAS on August 20<sup>th</sup>, 2020, Student Association, in consultation with University Centers, mandated that all student organizations host online meetings for the first four weeks of the Fall 2020 semester for groups larger than 20 individuals; and

WHEREAS on September 9<sup>th</sup>, 2020, Student Senate approved and upheld Executive Order 2021-003 that enforced the guidelines above; and

WHEREAS given the current increase of positive COVID-19 cases on campus and the University's shelter-in-place order, Student Association and University Centers is mandating that student organizations host online meetings until October 19<sup>th</sup>; and

WHEREAS Student Association and University Centers will allow student organizations to meet in-person for groups of ten individuals or less starting October 19<sup>th</sup>; and

WHEREAS student organizations that fail to comply with Resolution SA2021-014 will be referred to the Student Organization Committee for review;

THEREFORE BE IT RESOLVED the Student Senate mandates that all student organizations continue to meet virtually until October 19<sup>th</sup>, 2020.

## EXECUTIVE ORDER 2021-003

FOR IMMEDIATE RELEASE

### STUDENT ORGANIZATION IN-PERSON MEETINGS FOR FALL 2020

LA CROSSE, WISC – Student Association, in consultation with University Centers, is mandating that all student organizations host online meetings for the first four weeks of the Fall 2020 semester for groups larger than 20 individuals. All student organizations that decide to meet in-person on campus may only meet in the Student Union. For room reservations, student organizations should refer to the COVID-19 Social Distancing Room Capacities in Appendix A.

Student organizations can submit official requests to University Centers, with the requirement that meetings are held in open spaces and follow the guidelines of the La Crosse County Health Department. Student Association and University Centers will reevaluate in-person meetings for student organizations during September.

Student organizations that fail to comply with Executive Order 2021-003 will be sent to the Student Organization Committee for review. The Student Organization Committee will decide on a case by case basis if the situation at hand can be resolved internally or if the case will be referred to the Student Court.
