As with other campuses, concerns about TTC, lack of clear appeal process and losing university staff to academic staff with new hires (hourly vs. salary). Concerns about overall morale due to confusion and uncertainty. Dan Chanen, UW System Associate VP and Chief HR Office had a TTC presentation, starting out why TTC was created and then went directly into Q&A with those in attendance. Interested staff can attend the virtual town halls on 11/9 and 11/18. Beginning early November (I believe starting 11/8) employees should receive their employee notification letters with specific job title/classification and attached salary grade (then you'd need to reference the salary range info).

The Chancellor provided good feedback. This week meeting to discuss and vote on green fund grants.

JPB met on Oct 27. Chancellor Gow talked about vaccination rates at UWL and Madison. He noted President Tommy Thompson would call for a 100 % vaccine rate to comply with the

Looking to Mayo clinic for assistance. CFO Bob Hetzel talked about the CIO interviews the first two weeks in November.
