## Joint Planning and Budget

Enrollment headcount is up this year, but enrollment FTE is down as students are taking fewer credits. Summer session has been decreasing since 2014 and Summer tuition dollars go into the central tuition fund. There is around \$250k shortfall in the central fund and these factors combined with adjusted transfer student goals for Spring 17, UWL is short around \$450k. Therefore, there will be a reduction in 5 faculty and 1 staff GQA positions for FY18.
