Re: Q4 Preview of Fiscal Year 2021 UW System Administrative Policy Priorities

In the past quarter, UW System Administration (UWSA) has made progress on several policy priorities on the Fiscal Year 2021 Policy Priorities plan and has been responding to new policy priorities as they arise. In the third quarter (January 1, 2021 through March 31, 2021), there were five new system administrative policies, seven revised policies, two rescinded policies, one new procedure, and two revised procedures that were approved. There were also two new interim policy actions approved. This work was detailed in the monthly Policy Action Summary memos.

Below, please find a detailed accounting of policies that have already been distributed to institutions and are planned for finalization and approval (section I). III. FY 2022 POLICY PRIORITIZATION PROCESS

On Friday, April 2, 2021, the Office of Administrative Policies began the FY 2022 SYS Policy Prioritization Process. Key dates for institutions are listed below:

- **Friday, April 2** Policy Prioritization Form sent to institution leadership.
 - Institutions were asked to compile their feedback and provide one response with up to five (5) policy recommendations. Recommendations can be to:
 - draft a new policy;
 - revise an existing policy;
 - merge existing policies; or
 - rescind an existing policy.
- **Friday, April 16** Two-week reminder to be sent regarding Policy Prioritization Form.
- Monday, April 16- Four-day reminder to be sent regarding Policy Prioritization Form.
- Friday, April 30- Institution Policy Prioritization Form Responses are due.
- **Week of Friday, June 25** Final FY 2022 Policy Prioritization Memo to be distributed to institutions.
