Re: Q2 Preview of Fiscal Year 2022 UW System Administrative Policy Priorities

In the past quarter, UW System Administration (UWSA) has made progress on several policy priorities on the Fiscal Year 2022 Policy Priorities plan and has been responding to new policy priorities as they arise. In the first quarter (July 1, 2021 through September 31, 2021), there were three new system administrative policies, fourteen revised policies, one rescinded policy, one new procedure, and one new guidance document that were approved. One new interim policy action and one revised policy action were also approved. This work was detailed in the monthly Policy Action Summary memos.
