"Current as of" defines when the last pay date was for our employee. We pay on a monthly or bi-weekly schedule. For our faculty, they are paid on a 9-month basis; summer verifications may show a several months gap in payment dates.

"Verified On" date refers to when the data was refreshed in The Work Number system. UW System refreshes the data three times a week. If this date and the "Current as of" date do not align, this means the employee is still active, but on an irregular contract.

If this box says "ACTIVE" it means that the employee is still active in our system as of the "Verified on" date. If this box says "ACTIVE" then the employee has not been terminated, and is either receiving pay or will receive pay, based on their contact terms.
