- A. SHE 492, SHE 494, SHE 495:** At the April 12, 2022, UCC meeting, the courses were approved to be inactivated as of Summer 2022. The Records office changed the inactivation term to Summer 2023 to accommodate requirements of a small number of students still completing the program, which had been suspended.
- B. General Science Minor:** The new, non-certification General Science Minor was approved at the April 12, 2022, UCC meeting. The Records office requested the name be updated to "General Science for Teachers Minor" to reflect the minor is intended for teacher candidates only. The SOE Dean, Department of Educational Studies, and Physics Department were consulted and approved the name change.
- C. School of Education Policies:** The WI Department of Education changed their policy on minimum GPAs for teacher education program completion in February 2022. The state's graduation GPA benchmark is now based only on the combined cumulative GPA, and no longer examines major, minor etc. for the GPA. The School of Education updated their [Teacher Education Retention Policy](#) and the [Teacher Education Student Teaching and Internship Policy](#) to reflect this change in the 2022-23 catalog.
