# Please provide a short title for you proposed project:

Reusable Period Pantry Products

Provide an Abstract for your project. What changes/additions do you propose? What is are the basic impacts that you anticipate? What is your expected timeline?

- This Green Fund Grant requests funding for the purchase of 250 reusable menstrual cups, 30 reusable panty liners, 30 reusable mini pads, and 30 reusable maxi pads. These products would be offered as a part of the new "Period Pantry" section of the Food Pantry in the COVE, which provides free menstrual products for students. There is shelving available in the Period Pantry to store some of the reusable period products, and the UWL Student Association storage cage can be utilized to house any products that do not fit. As students take the products from the pantry, the products in the storage cage will be used to restock the shelves.
- The project will positively impact students because it will provide them with several sustainable period product options at no cost. Menstrual products are a necessity that can be difficult for students to afford, and sustainable alternatives can be especially expensive. This grant would make these products accessible for students and would address the issue of period poverty at UWL.
- The expected timeline for this project is to be completed by the Fall 2021 semester. If these products are ordered promptly and arrive during the summer, they would be stocked in the Period Pantry for students to use in the fall. The Student Association Executive Cabinet will be responsible for restocking the products.

Provide a detailed explanation of the environmental impact of your project on the UWL carbon footprint, water usage or electrical consumption. Be as specific and quantitative as possible. (If impacts are indirect, please explain).

Reusable menstrual products have a positive environmental impact because they eliminate waste from single-use menstrual products that would end up in the landfill. One Period Aisle brand reusable panty liner replaces 48 disposable pads, the mini pad replaces 239 disposable pads, and the maxi pad replaces 238 disposable pads. Reusable menstrual cups last at least 6 months but can last up to 10 years with proper care, thereby eliminating waste from months or even years of tampons. These reusable products also reduce greenhouse gas emissions and energy usage associated with the production of single-use menstrual products. Period Aisle estimates that one of their reusable panty liners saves 3.1 miles of driving emissions and 100.9 days of LED bulb energy when compared to disposable pads. The mini pad saves 18.8 miles of driving emissions and 615 days of LED bulb energy, while the maxi pad saves 18.4 miles of driving emissions and 602.8 days of LED bulb energy.

How will this increase student understanding of environmental issues? Will it be visible to students? This is an important aspect of the Green Fund. If your proposed project isn't visible to students have you added signage, informational materials or promotion to your request?

This will be visible to students because it will be advertised with signage and on social media. Cate Wiza will be putting graphics on the TVs in the Union, sending an email to students, posting on social media, and creating fliers to put on campus.

What does this proposed project look like in 5 years, 10 years, etc.? Are there ongoing maintenance costs, will this need to be replaced, will ongoing costs be absorbed by another UWL entity or will this project rely on the Green Fund?

 These products should last a while, but once they run out a new grant would need to be submitted to buy more. These costs would not be absorbed by another UWL entity.
