The College of Arts and Sciences is the largest college at the university, serving about 5,600 undergraduate and graduate students (about 25% of the student population enrolled at the university) and includes the bulk of our general education courses. We house 16 Departments and Schools with 69 bachelor's degree plans (including 11 distinct secondary teacher education programs), 44 master's degree plans of study, 9 certificate/specialist programs, and 8 doctoral degree plans of study. In my role as Associate Dean, I:
